

Assembly Participation

Participation Requirements for Members of The Georgia Assembly To actively participate and vote in the General Assembly you must have completed all required documents and letters that sever your ties to the U.S. Federal government.

- a. 1779 document and/or 928 package with two witness testimonies, recorded and published in the LRO.
- b. Birth Certificate (not published but kept on Assembly files)
- c. Complete our 'Affirmation and Purpose and Conduct form*

Paperwork Visual Guides and Explanations


Here is the guidance from Anna on the Deed of Conveyance:

"They –the new immigrants– are starting out "at sea" in the international jurisdiction of the sea and are conveying themselves to our land jurisdiction for the first time, therefore they use blue ink. When we re-convey back to the land jurisdiction of our State we are giving Notice to the sea jurisdiction authorities that we are back "home" on the land where we started out, which is why we sign in red and record the paperwork. We are native to these shores, not foreigners. We came from here and we are returning home— coming back after being shanghaied. The new immigrants are foreigners coming from overseas for the first time ever. Does it make sense that a person who goes on a sea voyage and then returns home is in a different position than a person who goes on a sea voyage and lands in a foreign country? Okay, so we use red and new immigrants use blue because we are starting out from different "places". We are native and they are naturalized. We come from this land and return to this land. They come from over the sea and come ashore here. End of story."

- For your Deed of Reconveyance (if you were born in America) you should autograph your name in red ink.
- For your Deed of Conveyance (if you were not born in America), you should autograph in blue Ink.
- For all other documents, you should autograph your name in blue ink.

 Be sure to include your copyright symbol after your name.
- Don't forget your red thumbprint seal.
- When editing the templates, be sure to remove the word Seal from the document.
- The autograph should be:

by: First Middle Last© (red thumbprint should touch your autograph)



Deed of Re-Conveyance & Baby Deed Only

Deed of Conveyance for Americans born overseas.

(Military, Foreign-Born to American mother/father.)

Deed of Conveyance & All Other Items
**Except for the two Deeds above.

Paperwork links

Decide in advance between using a Recording Secretary or a 'State of State' Notary.

The blocks on the bottom of the documents you choose are different for who will be 'witnessing' you autographing them.

Do Not autograph the docs until you are in front of either the Recording Secretary or the Notary

If you choose to have a Notary ('State-of-State'- corporation) witness you autographing your documents:

- prepare the documents that have 'Notary' on the bottom.
- Once completed and witnessed by a Notary,
- you can contact us to publish them on the Land Recording Office website

After your documents are published on the LRO, you can order your Credential Card and join your Assembly
